- Opportunities and Threats describe the external forces on the organization. (Political, Social, Economic, Environmental and Technical)

#### Regional Software Access Project

- Andrea Dupler, SEAT
- ODOT suggested a combined grant application of OMEGA through 5310 and SEAT through OPT2 to secure the needed funding.
- SEAT was awarded \$900,000 and OMEGA was awarded a nominal amount ( < \$5000)</li>
- Goal is to establish and utilize software access regionally

## **ODOT Project Scoring**

#### A new plan for updating the 5310 scoring system



- ODOT is taking the lead on updating the 5310 project scoring system (excluding mobility management program) to select projects which best advance the goals, address unmet needs, and demonstrate coordination in the region. Some of these projects will be regional in scope and some will be local but still aide in achieving the regional goals.
- The SC can add the most value to this process by focusing on the sections that pertain to coordination.

## Where can the SC be Most Effective in the Process?

ODOT wishes to be able to better recognize, promote, and fund projects which are regionally relevant and projects which promote coordination, both regionally and locally.

#### What can the SC do to help?

- The SC can make suggestions about changes, deletions, or additions to the Coordinated Plan Support Document (PSD) that is submitted with each 5310 application.
  - These suggestions need to be regional in scope, not Region
    9 specific.
- The SC can review and provide comment to ODOT when we receive the draft of the new scoring system

#### HOMEWORK ASSIGNMENT

- Review <u>ODOT Coordinated Plan Support Document.</u> It will be emailed to you after the meeting.
- Consider what would you look for in a project that would have it score maximum points for funding.
- Identify questions that need to be asked to demonstrate regional and/or local coordination efforts.
- Identify questions that need to be asked to demonstrate that the project aligns with regional goals and fulfills regional unmet needs or local critical needs.
- Identify information needed to provide equitable consideration for large and small projects
